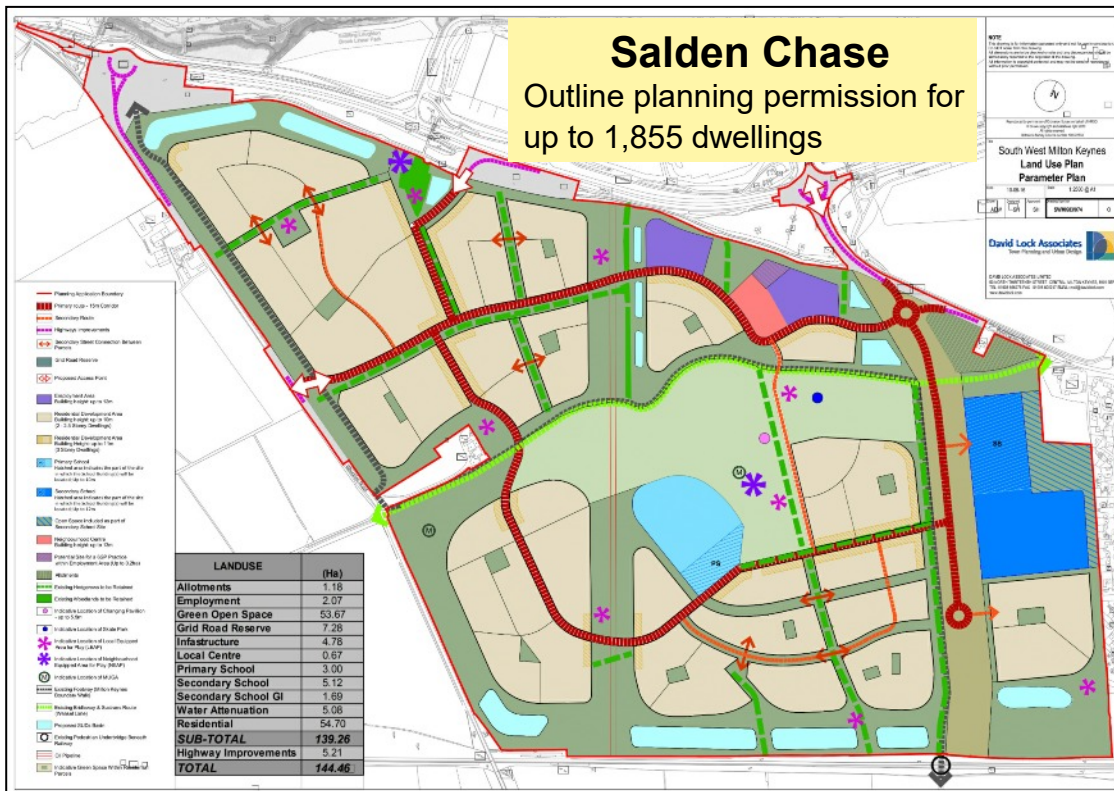

# Salden Chase planning application

**Outline planning permission for up to 1,855 dwellings, a primary school, an employment area, a neighbourhood centre and provision of land for a GP surgery and secondary school.**

After no news for over a year, changes have recently been to the plans by the applicants: called "South West Milton Keynes Consortium" even though the site is not in Milton Keynes.

The Village Alliance - the team of the Parish Council, Save our Village and Village Plan which successfully fought off the original Salden Chase - are working together to oppose these plans. We are also working closely with West Bletchley Council who are also against the application.

Help us fight to save the village from such a large development that would swamp the village.

The Village Alliance has considered the changes, and are still fundamentally opposed the application. We think some of the changes may even make things worse for Newton Longville and West Bletchley.

The applicants will be at the public meeting to explain the changes and answer questions.
